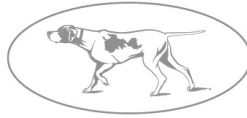

# COVID-19 PROTOCOL

The safety and security of all exhibitors, Judges and attendees at the show is paramount to The Westminster Kennel Club (WKC). Every effort will be made to maintain proper protocols at the event.

WKC has followed NY State Covid-19 Guidelines and Requirements & AKC Best Practices. Lyndhurst's own protocols will also be in effect during the show. These resources were used in developing an extensive show Covid Compliance Plan which has been approved by the NY State and Westchester County Departments of Health. The Westminster Kennel Club has engaged Reel Health, a health and safety firm, to administer this plan and to provide Covid-19 prevention services for the events.

For entry to the Lyndhurst grounds, all attendees must:

1. Provide proof of Covid-19 vaccination  
Or
2. Have a Negative Covid-19 PCR test performed by either one of the four approved national health providers (Curative, CVS, Rite Aid, Walgreens) or by Reel Health within 72 hours prior to their first entry time for these events.

You must either record proof of Covid-19 vaccination or results of your Covid-19 PCR test from either Curative, CVS, Rite Aid, Walgreens or Reel Health when registering on the Reel Health website.

At the show, requirements will include:

- Mandatory face masks or coverings ("PPE")
- Daily Temperature Checks
- 6 - feet social distancing rules
- Signed waivers when registering with Reel Health to be on the show grounds
- Special access wristbands

- 2-10 entries - 1 Award of Merit
- 11-20 entries - 2 Awards of Merit
- 21-30 entries - 3 Awards of Merit
- 31-40 entries - 4 Awards of Merit
- 41 + entries - 5 Awards of Merit

*“Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.”* This would include up-to-date rabies shot.

- Your exhibitor hangtag must be displayed upon entry.

- In order to expedite entry to the site, please follow the direction of the Tarrytown Village Police, as well as WKC security and Site Control personnel.
- Upon entering the front gate at Lyndhurst, Exhibitors should stay to the left and show your admission ticket(s) and show that you have the Reel Health App loaded on your phone.
- Continue on to the Reel Health COVID check in, where you will have your temperature checked & present your Reel Health App and identification to verify you have been cleared to enter the show site. Reel Health will collect your admission ticket and provide you with a wristband for placement on your left wrist.
- You will then be directed by Site Control to your parking space.

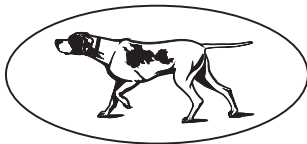

# **RULES AND PROCEDURES**

## **EXHIBITOR TICKET INFORMATION**

**NOTICE:** Groups and Best in Show seating will be VERY limited. Exhibitors, who remain on site, will be able to view the finals from monitors in an auxiliary tent as New York State COVID-19 compliance guidelines and restrictions allow.

After working closely with New York State officials regarding COVID-19 attendance restrictions for the 2021 dog show, the club will include two (2) exhibitor tickets per entered dog for daytime competition only, on the day the dog is exhibited. These passes will be part of each dog's entry packet. Owners of Best of Breed winners should go to the Superintendent's Office for information on attending the evening Group competition.

1. **DO NOT BRING ANY DOGS THAT ARE NOT ENTERED.** There is no provision for unentered dogs at this show. See also **Premium List pages 2, 9, 27, 31, 38.**
2. All regular exhibitor tickets, dog ID's, etc., are sent to the address noted on the entry form. Owners or the owners' duly authorized agent are responsible for the correctness. **No duplicate packets are mailed.** See **Premium List** page 12 regarding the Foreign Mail Option.
3. Regular exhibitor ticket packets returned by the Post Office marked "Undeliverable" are held at the show in the Superintendent's Office.
4. **NOTE: Juniors will receive a separate admission pass for all show days, two guardian tickets are also included. Misuse of this Junior Pass could result in an Event Committee hearing, removal from the show and/or exclusion from future competition at this show.**

## **PARKING**

To respect and preserve the historic grounds of the Lyndhurst Estate, RVs are not allowed on the grounds. Parking at the show will be limited to (Non-RV) vehicles (without trailers) not to exceed 30 feet (ALL INCLUSIVE) in total length. Exhibitor setups may be left on site Saturday overnight, but vehicles and dogs will need to be removed in compliance with municipal ordinances. **PERSONAL GOLF CARTS NOT ALLOWED ON SITE.** Please see the Westminster website for outside parking options and follow the directions of the Village of Tarrytown Police, Site Control and Security upon arrival to the show grounds.

1. There is NO overnight parking or accommodations.
2. Each Exhibitor packet will include a hangtag for Exhibitor parking in a lot on the Show Site. This hangtag is good for the day your dog is being shown ONLY. Due to COVID 19, a "Show and Go" policy is in place.

## JUDGING

1. The conformation judging starts promptly; no exception for tardiness. During the hours of judging exhibitors are to be on call and have their dogs ready to bring into the ring promptly.
2. The owner of the dog or the handler is responsible for the presence of their dog in the judging ring. There is no rule of this Club or the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.
3. **WRISTBANDS:** Exhibitor Wristbands will be given out each day as a part of our COVID-19 protocol and must be worn throughout the day on your left wrist.
4. **All cell phones, pagers, beepers, etc. must be on “mute” or “vibrate” when in or near the ring area. Persons with ringing or toning cell phones, pagers, beepers, etc. will be escorted from the ring area. No cell phone photos/videos are permitted.**
5. A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotti Romagnoli, Nova Scotia Duck Tolling Retrievers, American Water Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Grand Basset Griffon Vendeens, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs and Norrbottenspets (Misc.).

At the discretion of the judge, the following breed may be judged on a table or on a ramp through all levels of competition including Group and Best in Show judging: Mudik (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels, Whippets & Miniature Bull Terriers.

The following breeds must be judged on a ramp through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Bulldogs, Chinese Shar-Pei, Chow Chows and Keeshonden. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

## **LOSS OR DAMAGE**

1. The WKC, the Superintendent and site management will not be responsible for the loss or damage to any dog or property of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the time the dog is on the show premises. See also the Agreement on the reverse of the entry form.
2. The welfare of an exhibitor's/spectator's child is the responsibility of the exhibitor/spectator. It is expressly understood that exhibitors/spectators will exercise control and restraint over their children while they are on the show premises. The use of child strollers is NOT recommended.
3. The Westminster Kennel Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.

4. No entry fees are returned if the show cannot open or be completed by reason of riots, wars, civil disturbances, national emergencies, health emergencies, extreme weather conditions, fire and Act of God, public emergency, act of a public enemy, strikes, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or any other cause beyond the control of The Westminster Kennel Club, nor shall Lyndhurst or the Superintendent be liable in any way. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made. ## **EQUIPMENT**

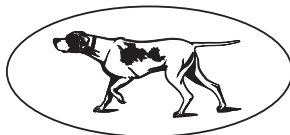
1. By entering this show, exhibitors and handlers agree to follow all directions of the special assistants charged with arranging and maintaining orderly conditions in the grooming areas. Abuse of these assistants will not be tolerated.
2. **Grooming will take place at the exhibitor's vehicle or in the grooming tent. Electric dryers are prohibited in the grooming tent. All crates/tack units must be stacked. There is no electric in the grooming tent. Please follow grooming tent and COVID protocol at ALL times. Exhibitors are expected to keep their grooming area clean. Exhibitors who set up in the grooming tent should remove their equipment promptly after exhibiting unless dog is required for Group judging.**
3. **No Flexi/retractable leads or stacking trainer equipment permitted at this show.**
4. **Fabric crates are not permitted at this show.**
5. **Public exercise pens will be for multiple dogs at all times. Dogs must be on lead in exercise pens. No exceptions. A separate area will be provided for bitches in season. Owners/handlers are to clean-up after their dogs. Blocking off exercise pens is NOT permitted.**

**No private exercise pens are permitted within the grooming tent at anytime. Private exercise pens are permitted at vehicle set-ups. Owner/Handlers are solely responsible for clean-up of their private exercise pens.**

6. **For the safety of all, no other tables and other furniture are allowed in the ring areas. No aisle obstruction is permitted.**
7. Handbills, circulars, or other printed matter may not be distributed at this show.
8. No gasoline or diesel powered generators are permitted within 100 feet of any tent in which the show is conducted. All cords must be secured to avoid tripping hazards.
9. Neither WKC, Lyndhurst, nor the Superintendent is responsible for any equipment or supplies or other belongings left on the show site.

## **AGREEMENT**

1. By entering this show, all participants agree to the following: All rights to advertise, promote, publicize, televise or otherwise exploit the show are vested in The Westminster Kennel Club and its assigns, including the use of the names, likenesses, voices or biographical matter of all dogs, owners, handlers, and kennels participating in the show.
2. **By entering, exhibiting or attending this show, all parties associated with the entry acknowledge, accept and agree, to comply at all times with all of the COVID-19 compliance requirements described herein, or as otherwise amended prior to or during the event. See also page 4.**
3. **The Club permits only its credentialed personnel to use any video recording devices for this show.**
4. The Westminster Kennel Club reserves the right to broadcast or cause to be broadcast any or all portions of The Westminster Kennel Club Dog show by any means of known transmission of video material.
5. The use of any Westminster Kennel Club logo, trademark or any other likeness associated with the Westminster Kennel Club is expressly prohibited without the written consent of the club.





# STEP-BY-STEP DIRECTIONS

**There will be one main entry gate and one exit for the show at Lyndhurst. Please follow the directions of Tarrytown Village Police and Security on site. Travel directions are as follows:**

## **By Car**

### **From Westbound 287**

#### **(from Eastern Westchester/Connecticut):**

Take 287 west/87 North to the last exit before the Mario Cuomo Bridge, exit 9 off the NY State Thruway, marked Route 9 Tarrytown. Take a left onto 119 at the first stoplight and a left (south) onto Route 9 at the second stoplight. The Lyndhurst gates are ½ mile on the right-hand (river) side of the road.

#### **From Eastbound 287 (from Rockland/New Jersey):**

Take 287 east across the Mario Cuomo Bridge. Immediately after the toll booth, take the first exit, Exit 9. Turn left (south) onto Route 9 and proceed ½ mile to the Lyndhurst gates on the right-hand (river) side of the road.

#### **From New York City's East Side:**

Drive north on the East River Drive, across the Willis Avenue Bridge onto the Major Deegan Expressway North. Follow the Deegan to the NY State Thruway (I-87) to Westbound 287 (Mario Cuomo Bridge). Follow westbound 287 directions above.

#### **From New York City's West Side:**

Drive North on the West Side Highway to the Henry Hudson north to the Saw Mill Parkway north to the NY State Thruway (I-87) North to 287 West (Mario Cuomo Bridge). Follow westbound 287 directions above.

#### **From Connecticut:**

Take either I-95, I-684, or the Merritt Parkway South to 287 West (to the Mario Cuomo Bridge). Follow westbound 287 directions above.

#### **From Long Island:**

Take either:

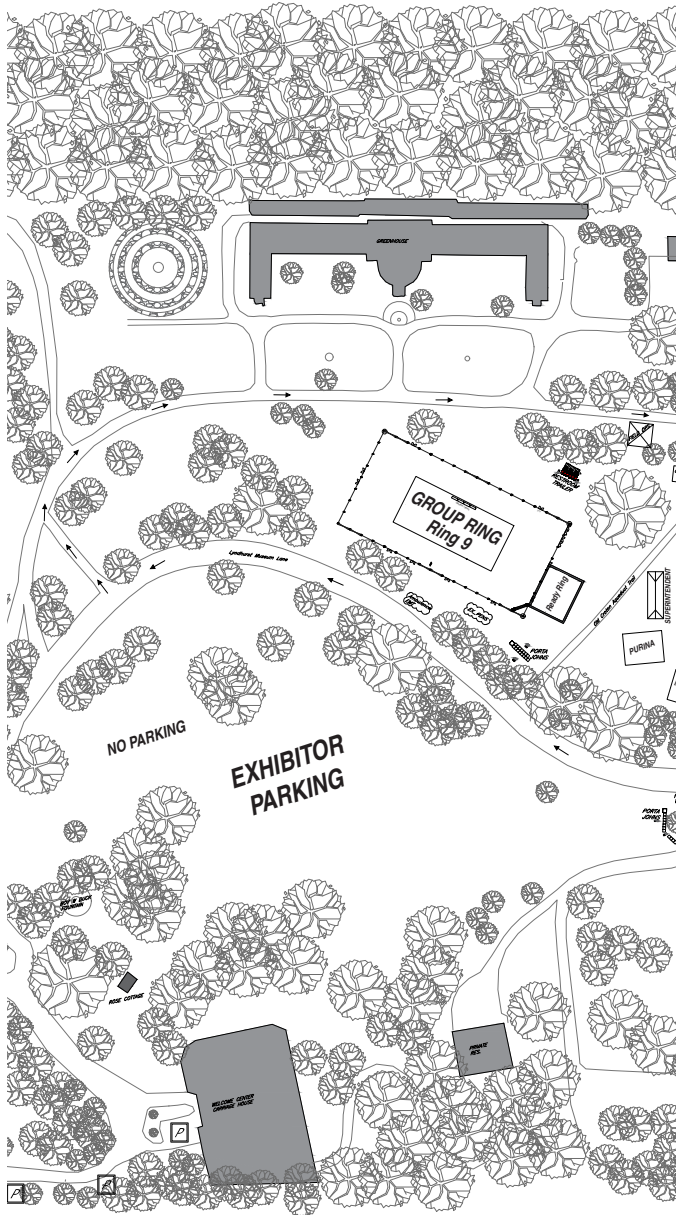

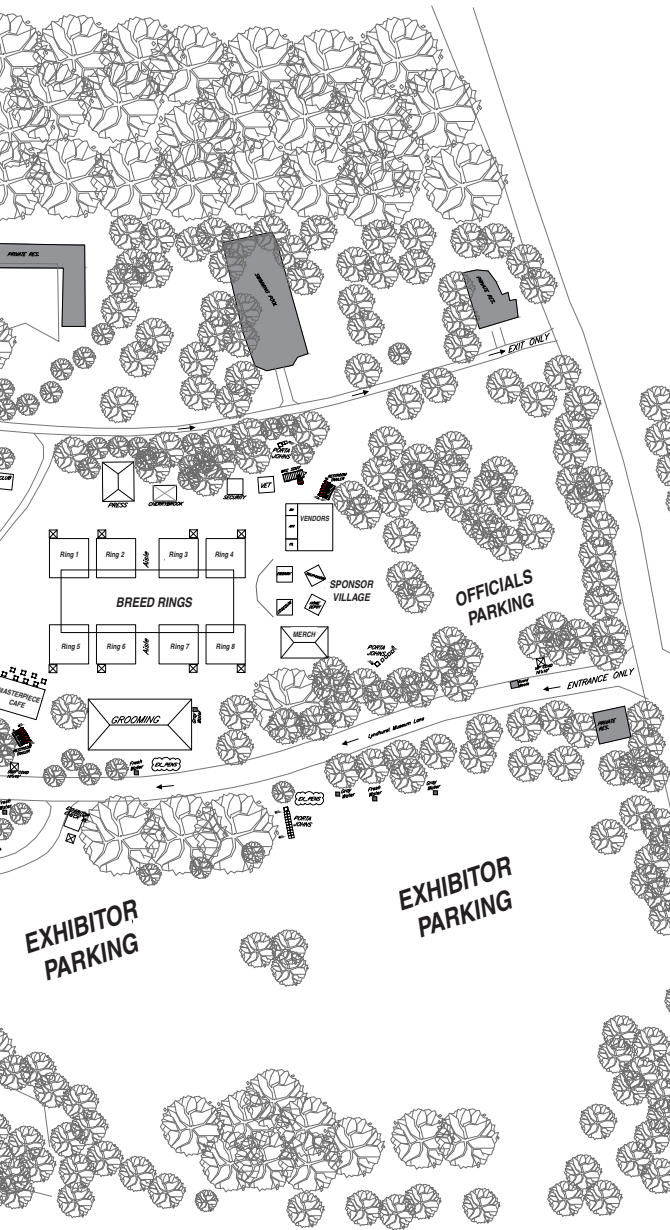
