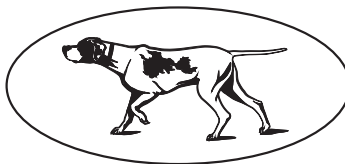

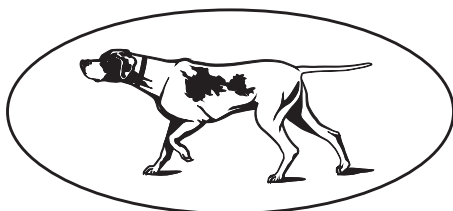

# **RULES AND PROCEDURES**

## **EXHIBITOR TICKET INFORMATION**

1. **Regardless** of the ownership of the dog(s) two (2) exhibitor's gate admissions per entry good for the day your dog is entered will be sent and are needed for admittance. For additional ticket purchases prior to the Show, please see our website. The person accompanying the dog must show an admission ticket and the dog identification before the dog will be admitted. **DO NOT BRING ANY DOGS THAT ARE NOT ENTERED.** There is no provision for unentered dogs at this show. **See also Premium List pages 8, 11-13, 22, 28, 35.**
2. All regular exhibitor tickets, dog ID's, etc., are sent to the address noted on the entry form. Owners or the owners' duly authorized agent are responsible for the correctness. **No duplicate packets are mailed.** See also page 5. (See Premium List page 12, item #8 regarding the Mail Options, including Foreign.)
3. Regular exhibitor ticket packets returned by the Post Office marked "Undeliverable" are held at the show in the Superintendent's Office.
4. **NOTE: Juniors receive a separate admission pass plus two guardians tickets per entry for all show days. Misuse of this Junior Pass could result in an Event Committee Hearing, removal from the show and/or exclusion from future competition at this show.**

## **PARKING**

To respect and preserve the historic grounds of the Lyndhurst Estate, RVs are not allowed on the grounds. Parking at the show will be limited to (Non-RV) vehicles (without trailers) not to exceed 30 feet (ALL INCLUSIVE) in total length. Exhibitor setups may be left on site Monday and/or Tuesday overnight, but vehicles and dogs will need to be removed in compliance with municipal ordinances. **PERSONAL GOLF CARTS NOT ALLOWED ON SITE.** Please see the Westminster website for outside parking options and follow the directions of the Village of Tarrytown Police, Site Control and Security upon arrival to the show grounds.

1. There is NO overnight parking or accommodations.

2. RV Parking is available at the Mid-Hudson Cluster Show grounds. Please consult our website for additional information and details.
3. Each Exhibitor packet will include a hangtag for Exhibitor parking in a lot on the Show Site. This hangtag is good for the day your dog is being shown ONLY.

## JUDGING

1. The conformation judging starts promptly; no exception for tardiness. During the hours of judging exhibitors are to be on call and have their dogs ready to bring into the ring promptly.
2. The owner of the dog or the handler is responsible for the presence of their dog in the judging ring. There is no rule of this Club or the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.
3. **All cell phones, pagers, beepers, etc. must be on “mute” or “vibrate” when in or near the ring area. Persons with ringing or toning cell phones, pagers, beepers, etc. will be escorted from the ring area. No cell phone photos/videos are permitted.**
4. **The following breeds must be judged on a ramp** through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

5. **WRISTBANDS:** BOB/V Winners will receive Wristbands which must be worn for access to the Group Rings.

## **LOSS OR DAMAGE**

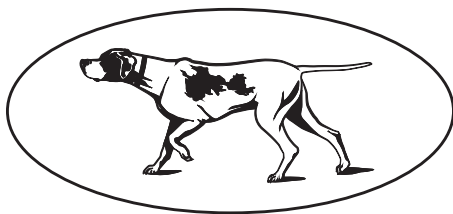
1. The WKC, the Superintendent and site management will not be responsible for the loss or damage to any dog or property of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the time the dog is on the show premises. See also the Agreement on the reverse of the entry form.
2. The welfare of an exhibitor's/spectator's child is the responsibility of the exhibitor/spectator. It is expressly understood that exhibitors/spectators will exercise control and restraint over their children while they are on the show premises. The use of child strollers is NOT recommended.
3. The Westminster Kennel Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.
4. No entry fees are returned if the show cannot open or be completed by reason of riots, wars, civil disturbances, national emergencies, health emergencies, extreme weather conditions, fire and Act of God, public emergency, act of a public enemy, strikes, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or any other cause beyond the control of The Westminster Kennel Club, nor shall Lyndhurst or the Superintendent be liable in any way. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made. ## **EQUIPMENT**

1. By entering this show, exhibitors and handlers agree to follow all directions of Site Control charged with arranging and maintaining orderly conditions in the grooming areas.
2. **Grooming will take place at the exhibitor's vehicle or at the grooming tent. Grooming of dogs in areas other than those specified is not permitted. All crates/tack units must be stacked in the grooming tent. Exhibitors are expected to keep their grooming area clean. Exhibitors who set up in the grooming tent should remove their equipment promptly after exhibiting unless dog is required for Group**
3. **No Flexi/retractable leads or stacking trainer equipment permitted at this show.**
4. **Fabric crates are not permitted at this show.**
5. **Public exercise pens will be for multiple dogs at all times. Dogs must be on lead in exercise pens. No exceptions. A separate area will be provided for bitches in season. Owners/handlers are to clean-up after their dogs. Blocking off exercise pens is NOT permitted.**  
  
**No private exercise pens are permitted within the grooming tent at anytime. Private exercise pens are permitted at vehicle set-ups. Owner/Handlers are solely responsible for clean-up of their private exercise pens.**
6. **For the safety of all, no other tables and other furniture are allowed in the ring areas. No aisle obstruction is permitted.**
7. Handbills, circulars, or other printed matter may not be distributed at this show.
8. Generators will be **ONLY** permitted at your setup in the parking lot and 25' from the south side of the grooming tent. All cords must be secured to avoid tripping hazards.
9. Neither WKC, Lyndhurst, nor the Superintendent is responsible for any equipment or supplies or other belongings left on the show site.

## AGREEMENT

1. By entering this show, all participants agree to the following: All rights to advertise, promote, publicize, televise or otherwise exploit the show are vested in The Westminster Kennel Club and its assigns, including the use of the names, likenesses, voices or biographical matter of all dogs, owners, handlers, and kennels participating in the show.
2. **By entering, exhibiting or attending this show, all parties associated with the entry acknowledge, accept and agree, to comply at all times with all of the COVID-19 compliance requirements described herein, or as otherwise amended prior to or during the event. See also page 4.**
3. **The Club permits only its credentialed personnel to use any video recording devices for this show. THIS INCLUDES CELL PHONE RECORDINGS.**
4. The Westminster Kennel Club reserves the right to broadcast or cause to be broadcast any or all portions of The Westminster Kennel Club Dog show by any means of known transmission of video material.
5. The use of any Westminster Kennel Club logo, trademark or any other likeness associated with the Westminster Kennel Club is expressly prohibited without the written consent of the club.





# STEP-BY-STEP DIRECTIONS

**There will be one main entry gate and one exit for the show at Lyndhurst. Please follow the directions of Tarrytown Village Police and Security on site. Travel directions are as follows:**

## **By Car**

### **From Westbound 287**

#### **(from Eastern Westchester/Connecticut):**

Take 287 west/87 North to the last exit before the Mario Cuomo Bridge, exit 9 off the NY State Thruway, marked Route 9 Tarrytown. Take a left onto 119 at the first stoplight and a left (south) onto Route 9 at the second stoplight. The Lyndhurst gates are ½ mile on the right-hand (river) side of the road.

#### **From Eastbound 287 (from Rockland/New Jersey):**

Take 287 east across the Mario Cuomo Bridge. Immediately after the toll booth, take the first exit, Exit 9. Turn left (south) onto Route 9 and proceed ½ mile to the Lyndhurst gates on the right-hand (river) side of the road.

#### **From New York City's East Side:**

Drive north on the East River Drive, across the Willis Avenue Bridge onto the Major Deegan Expressway North. Follow the Deegan to the NY State Thruway (I-87) to Westbound 287 (Mario Cuomo Bridge). Follow westbound 287 directions above.

#### **From New York City's West Side:**

Drive North on the West Side Highway to the Henry Hudson north to the Saw Mill Parkway north to the NY State Thruway (I-87) North to 287 West (Mario Cuomo Bridge). Follow westbound 287 directions above.

#### **From Connecticut:**

Take either I-95, I-684, or the Merritt Parkway South to 287 West (to the Mario Cuomo Bridge). Follow westbound 287 directions above.

#### **From Long Island:**

Take either:

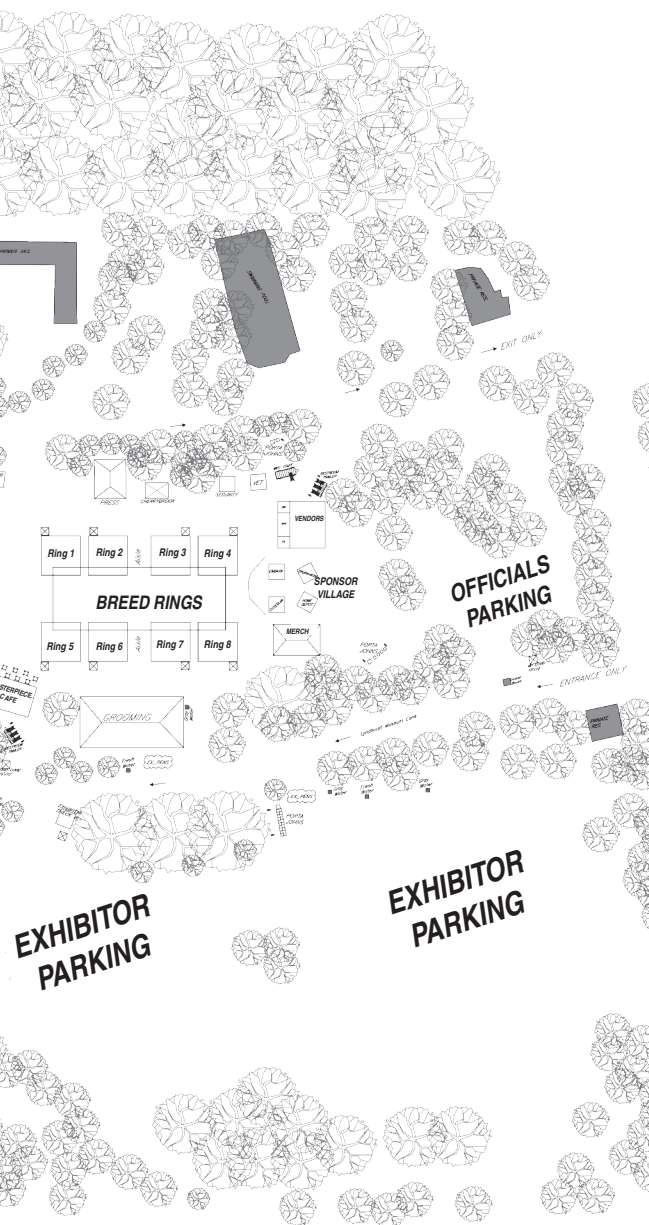

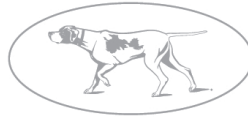
#### **Taxi and other ride services**
