- 2-10 entries 1 Award of Merit
- 11-20 entries 2 Awards of Merit
- 21-30 entries 3 Awards of Merit
- 31-40 entries 4 Awards of Merit
- 41 + entries 5 Awards of Merit

## **IMPORTANT**

TRANSFERS by Junior Handlers to a different Ring or a different day should be done prior to the start of the first Junior Limited Class on Monday. SUBSTITUTIONS of Junior Showmanship dogs must be made prior to the judging of the class at the show.

Juniors, who substitute for the original dog they have entered in the Junior Showmanship Class with dogs that are not entered in one of the offered classes at this show, will not incur an additional fee.

#### ENTERING THE SITE

- Gates at Parking Lot A will open at 6:00 AM for Exhibitors unloading and entry. Consult the judging program for all ring times.
- Your vehicle hangtag must be displayed upon entry and during vehicle staging. Please remember to add your cell number to this tag.
- In order to expedite entry to the site, please follow the directions of Site and Security Personnel.
- Exhibitors will be checked in by MB-F upon arrival.
- Handstamps will be given each day for easy access in and out of the grounds.
- You will be directed by Site Control where to unload your dogs and directed to the Grooming Tent. After unloading, proceed to the Queens Hall of Science to park. You must have your exhibitor hangtag on the rearview mirror to access this lot. One hangtag per entered dog was sent with your entry for the day your dog is shown.
- Spectator parking will be available at Citi Field. (see WKC website: westminsterkennelclub.org for details)
- Monday exhibitors can arrive at Parking Lot A at the USTA on Sunday at 3 p.m. to unload and set up for Monday.
- Monday dogs can be left in the grooming tent overnight on Sunday night by signing a waiver.
- Tuesday dogs can be left in the grooming tent overnight on Monday night by signing a waiver (after 7 p.m.)
- All dogs MUST be out of the grooming tents by Midnight on Tuesday night.





#### **EXHIBITOR TICKET INFORMATION**

- 1. Regardless of the ownership of the dog(s) two (2) exhibitor's gate admissions per entry good for daytime and nightime for the day your dog is entered will be sent to you and are needed for admittance. The person accompanying the dog must show an admission ticket and the dog identification before the dog will be admitted. DO NOT BRING ANY DOGS THAT ARE NOT ENTERED. There is no provision for unentered dogs at this show. Exhibitors must preserve their dog identifications and have available on the showgrounds if needed. See also Premium List pages 13-14, 24, 35.
- All regular exhibitor tickets, dog ID's, etc., are sent to the e-mail and postal addresses noted on the entry form. Owners or the owners' duly authorized agent are responsible for the correctness. No duplicate packets are mailed. See Premium List page 13, item #8 regarding the Mail/Hold for pick-up Options, including Foreign.
- Regular exhibitor packets returned by the Post Office marked "Undeliverable" are held at the show at the Superintendent's Office.
- 4. NOTE: Juniors receive a separate admission pass plus two guardians tickets per entry for all show days. Misuse of this Junior Pass could result in an Event Committee Hearing, removal from the show and/or exclusion from future competition at this show.

When entering the event, please keep your Exhibitor hangtag on the rearview mirror (and write your cell on it before hanging). In order to get everyone in and out efficiently, we suggest that you have an extra person with you to assist with the move in and stay with your dog(s) in the grooming tent while the second person parks the car in Exhibitor Parking at the nearby Queens Hall of Science. Please follow signs from Parking Lot A to the Hall of Science after unloading. Site Control personnel will be on hand to assist you with staging, directions and unloading.

Shuttles will be running to get you back to the USTA grooming tent after parking your vehicle (the ride is less than 10 minutes).

Shuttles will also be running between the LaGuardia Marriott, LaGuardia Plaza/Hampton Inn and Aloft Hotels on Ditmars Blvd. and Parking Lot A.

1. There is NO RV Parking available.

 Each Exhibitor packet will include a hangtag for Exhibitor parking in a lot on the Show Site. This hangtag is good for the day your dog is being shown ONLY.

#### JUDGING

- The conformation judging starts promptly; no exception for tardiness. During the hours of judging exhibitors are to be on call and have their dogs ready to bring into the ring promptly.
- The owner of the dog or the handler is responsible for the presence of their dog in the judging ring. There is no rule of this Club or the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.
- 3. All cell phones, pagers, beepers, etc. must be on "mute" or "vibrate" when in or near the ring area. Persons with ringing or toning cell phones, pagers, beepers, etc. will be escorted from the ring area. No cell phone photos/ videos are permitted.
- 4. The following breeds must be judged on a ramp through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows & Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. The full policy and list of Table and Ramp eligible/required breeds is available on the AKC website at:

Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

5. **WRISTBANDS:** BOB/V Winners will receive Wristbands which must be worn for access to the Group Rings.

#### LOSS OR DAMAGE

- 1. The WKC, the Superintendent and site management will not be responsible for the loss or damage to any dog or property of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the time the dog is on the show premises. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.
- 4. No entry fees are returned if the show cannot open or be completed by reason of riots, wars, civil disturbances, national emergencies, health emergencies, extreme weather conditions,

## **EQUIPMENT**



Exhibitors who set up in the grooming tents should remove their equipment promptly after exhibiting unless dog is required for Group Judging. See Premium List pages 5, 6, 12-14, 33-37.
- 3. No Flexi/retractable leads or stacking trainer equipment permitted at this show.
- 4. Fabric crates are not permitted at this show.
- 5. Public exercise pens will be for multiple dogs at all times. Dogs must be on lead in exercise




